

## Terms of participation in trips Active in Nature

### 1. Application for the trip

1.1. Application for the trip takes place in the moment when one:

- has sent the form which is located under each offer of the trip at the bottom

During completing the form please enter your Name and Surname.

- after sending the form the participant receives the GTC contract which has to be signed and sent on this email: [kontakt@active-in-nature.eu](mailto:kontakt@active-in-nature.eu)

- advance payment (up to 3 working days after sending the form)

- payment of the total price of the trip has to be made not later than 30 days before the event

- in case of signing for the trip less than 30 days before the event's start, one must pay all the above amount.

- in case of no advance payment and failure of delivery of the required documents within the deadline, will be treated as a resignation.

1.3 Active in Nature reserves the right to change the price of the trip by 5% maximum of the total costs of the trip in case of international travels due to increased transportation costs, official fees, taxes, airport charges, as well as a change in the exchange rate what affects the costs.

### 2. Realization of the trip

2.2 The Participant is obliged to obey the regulations and other regulations and customary law present in the country of stay, accommodation facilities, gastronomic facilities as well as recommendations of the leader.

2.3 Active in Nature reserves the right to cancel the event for the reasons which are beyond our control (decision of the authorities, force majeure) and in case of insufficient number of participants specified in the terms of the event. If the event is canceled due to insufficient number of people, Active in Nature notifies the Participant no later than 14 days before departure. In such cases the Participant will receive an immediate refund of the fees paid. In such situation the participant is not entitled to any compensation.

2.4 The Participant is provided with the information about the specific health and life hazards on the visited site and declares the awareness of the risks involved and that there are no medical contraindications to travel.

2.5 The Participant is obliged to have valid documents to cross the border.

### 3. Resignation from the trip

3.2 The Participant may only resign from participation in a written form and also in an electronic form. The date of receipt of the statement by Active in Nature is assumed as the date of resignation. Resignation must include the date of its submission. If the participant resigns for the reasons from the Active in Nature part, that is: changes in important conditions of the trip. The Participant receives a refund of all contributions paid.

3.2 If a Participant resigns from participation in the event for one's own reasons. Active in Nature calculates the cancellation costs to cover the costs and expenses incurred by Active in Nature in connection with the preparation of the event and makes deductions.
